Rightship Reduces Trigger Age for Inspections to 14

Effective 1st January 2018 Rightship's age trigger for a dry cargo inspection for vessels over 8000 dwt has changed from 18 years to 14 years, after which an annual acceptable Rightship Inspection will be required. This reflects the changing market conditions of the Bulk Carrier fleet, and as per Rightship it has been done with consideration of the following;

International Union of Marine Insurance figures reveal an increase in total bulker losses in the 15 to 19 age bracket in the period 2012 - 2016
It is important that the inspeciton is conducted prior to the 3rd special survey in order to identify focus areas for consideration.

The influx of new builds in the early 2000's has raised questions about the effective working life of vessels and accelerated pace of scrapping.




Eskomarine signs a new agreement with Norsepower of Finland

On 15th of February Eskomarine signed a new Exclusive Agreement with Norsepower of Finland by which we continue to bring new innovation to the Turkish Shipping Industry. The Norsepower Rotor Sail Solution is a modernized version of the Flettner rotor – a spinning cylinder that uses the Magnus effect to harness wind power to propel a ship. When the wind conditions are favourable, Norsepower Rotor Sails allow the main engines to be throttled back, saving fuel and reducing emissions while providing the power needed to maintain speed and voyage time. Rotor sails can be used with new vessels or they can be retrofitted to existing ships.

Norsepower has won a number of awards for the innovative Rotor Sail technology. In September 2015 the Norsepower Rotor Sail Solution won the Energy Efficiency Solution Award in annual Ship Efficiency Awards, organized by Fathom Maritime Intelligence. In June 2016 the product was awarded with the Innovation of the Year Award at the Electric & Hybrid Marine Awards.



The Norsepower Rotor Sail Solution was installed in November 2014 on board Bore's Estraden. Based on the independently verified results, the technology has potential for fuel savings of up to 20% for vessels with multiple, large rotors traveling in areas with favourable wind conditions. Norsepower Rotor Sails are suitable for installation on ships, which have the required installation space available space on deck. Typically such vessels are Ro-Ro ships, tankers, bulk carriers and cruise passenger vessels
